Semiconductor Update

Q1 | 2017

MARKET HIGHLIGHTS

After a slower performance in the last quarter of 2016, the semiconductor industry still outperformed the S&P 500 over 3 months, with an increase of 7.3% for the Semiconductor & Semiconductor Equipment Index. The index substantially outperformed the S&P 500 over 6, 12 and 24 months.

All sectors showed a good performance over 3 months; with a median gain of 15.4% for the Equipment segment, 10.4% for the EDA&IP segment, and 9.8% for the IDM/Foundry segment, respectively. The sectors were up between 18.3% and 49.5% compared to one year ago.

Within the IDM/Foundries segment, stock price changes over 3 months ranged from +34.7% (STM; up 175.8% over one year!) to -10.7% (Toshiba). Within the Fabless segment, AMD continues its strong performance with an increase of 28.3% - and visibility into profitability. AMD showed an impressive gain over one year: 410.5%. Qualcomm is down 12.1% after its acquisition announcement of NXP. The Semiconductor Equipment segment performed consistently well, with price increases ranging from 10.7% (Advantest) to 51.8% (ULVAC). The EDA/IP segment saw increases between 24.5% (Cadence) and -4.6% (Rambus).

After slowing down in the fourth quarter, valuation momentum is again picking up for most segments. With the exception of the median EBITDA multiple in the fabless segment, all other multiples saw expansion compared to 3 and 12 months ago.

After the flurry of deals towards the end of the year, few large transactions were announced in the first quarter, with Intel's acquisition of Mobileye (for 44x revenue none the less) stealing the spotlight – and ringing in increased competition for in-vehicle semiconductor content. Analog Devices' acquisition of Linear Technology closed (at 10.7x Revenue), as did Siemens' acquisition of Mentor Graphics (at 3.6x revenue – but almost identical EBITDA multiples).
